#### **NOTICE TO USER**

## **FIRST AID**

## KEEP OUT OF REACH OF CHILDREN.

Avoid contact with eyes and skin. Causes painful stinging or burning of eyes and lids.

Prolonged contact with skin may cause irritation in some individuals. Wear long-sleeved shirt, long pants, socks and shoes during mixing, loading, applying, clean-up and repair. ## **STORAGE**

Keep in original container tightly closed in a safe place when not in use. Store in a cool and dry location away from oxidizing and reducing agents. Keep away from heat, sparks and sources of ignition. Store this product away from food or feed.

# **SPILL CLEANUP**

Eliminate sources of ignition and ventilate area. Soak up spill with absorbent material (kitty litter, granular clay, earth) and collect into a waste container. Wash spill site with water after material pick-up and dispose with waste. See DISPOSAL statement below.

## For recyclable containers:

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

- 1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
- 2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

## For refillable containers:

For disposal, this container may be returned to the point of purchase (distributor/dealer). It must be refilled by the distributor/dealer with the same product. Do not use this container for any other purpose.

### **DIRECTIONS FOR USE**

**ASTRAL ADJUVANT** Non-Ionic Wetting & Spreading Agent mixes with all types of water. The rate of **ASTRAL ADJUVANT** Non-Ionic Wetting & Spreading Agent is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products

Pinnacle®, REFLEX®	1 L/1000 L	Add this product as the last ingredient. An antifoam agent may be required. Consult each product label for use.
Classic®, Escort®, PEAK® 75WG	2 L/1000 L	Add this product as the last ingredient. An antifoam agent may be required. Consult each product label for use.
Pursuit®, Distinct®, Upbeet®	2.5 L/1000 L	Add this product as the last ingredient. Consult each product label for use.
Washing Out Spray Tanks and Equipment	30 mL/50 L	Dispose of wastes according to municipal and provincial requirements. See DISPOSAL statement.
