Response:

4. FIRST AID MEASURES

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

5. FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: For small fire: dry chemical powder, water spray carbon dioxide. For large fire: foam, water fog, water spray.

SPECIAL EXPOSURE HAZARDS: Flashback may occur along vapor trail.

FIRE AND EXPLOSION HAZARDS: Dangerous gases are evolved in the event of a fire.

FIRE FIGHTING PROCEDURES: Fight fire from a safe distance and protected location. Fight fire upwind to avoid hazardous vapors and decomposing products. Heat may build pressure and rupture closed containers, spreading fire and increasing the risk of injury. Empty containers may contain residue product and can be dangerous. Use water spray/fog for cooling containers and firefighters. Notify proper authorities if liquid material enters the sewer or public waters.

FIRE FIGHTING EQUIPMENT: As with any fire, wear self-contained breathing apparatus pressure demand, (MSHA/NIOSH approved or equivalent) and full protective gear.

6. ACCIDENTAL RELEASE MEASURES

Further accidental release measures:

Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Avoid the formation and build-up of dust - danger of dust explosion. Dust in sufficient concentration can result in an explosive mixture in air. Handle to minimize dusting and eliminate open flame and other sources of ignition.

Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Use personal protective clothing. Avoid contact with the skin, eyes and clothing.

Environmental precautions

Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/groundwater.

Methods and material for containment and cleaning up

Avoid raising dust. Sweep/shovel up. Place into suitable containers for reuse or disposal in a licensed facility. Spilled substance/product should be recovered and applied according to label rates whenever possible. If application of spilled substance/product is not possible, then spills should be

contained, solidified, and placed in suitable containers for disposal. After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

7. HANDLING AND STORAGE

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE:

Advice on safe handling Handle and open container in a manner as to prevent spillage. Avoid contact with skin, eyes and clothing. Use only in area provided with appropriate exhaust ventilation. Advice on protection against fire and explosion Keep away from heat and sources of ignition. Hygiene measures Handle in accordance with good industrial hygiene and safety practice. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, using the toilet or applying cosmetics. Remove Personal Protective Equipment (PPE) immediately after handling this product. Before removing gloves clean them with soap and water.
